3.	Last Date of submission of the Duly Attested Verified Candidate Lists by the Govt. Colleges, within State, to this Directorate. (The Govt. Colleges (within State) need to retain the Printed Hard Copies, at their end).	10 th November, 2016
4.	Last Date of submission of the Duly Attested Verified Candidate Lists & Printed Application Forms by the Private Colleges & Govt. / Private Universities / Professional / Technical Institutes, etc., within state, and Out of State Institutions, to this Directorate.	20 th November, 2016
5.	Last Date of Online verification of Applications by the DDHEs.	30 th November, 2016
6.	Last Date of submission of the Hard copies of the Verified Candidate List(s), by the DDHEs. (The DDHEs need to retain the Printed Hard Copies of Application Forms, of Private Institutes & return the remaining Hard copies to the concerned Govt. Schools).	15 th December, 2016

Note: No Dates shall be extended after the due dates. If any Institutes fails to verify/correcting online application, within the stipulated time frame, Institutes alongwith the authorities of the concerned institution, would be solely responsible for any lapse and no request to entertain any request of entertaining any Institutes after the due date would be considered.
