Subject: Regarding verification of particulars and documents of eligible students under Post Matric SC/ST/OBC Scholarship Schemes.

Memo,

It has come to the notice of the Directorate of Higher Education,(HP) that some Private/Govt. Institutions have not verified the particulars and documents of eligible SC/ST/OBC students for Scholarship properly under the Post Matric Scholarship Schemes.

In view of above, you are requested to verify the particulars and documents of SC/ST/OBC eligible students for Scholarship viz. on the Scholarship website hpepass.cgg.gov.in and NSP portal uploaded by the Institutions/ students from original documents provided by the concerned students to the Institutions and give actual details of amount of Maintenance Allowance and Fees as per approved fee structure by the State Govt. and guidelines issued by the Govt. of India as under:-

The guideline of the GOI is given as below

1. **Maintenance Allowance:** - The Maintenance allowance is payable from 1st April or from the month of admission, whichever is later, to the month in which the examinations are completed, at the end of the academic year (including maintenance allowance during holidays), provided that if the scholar secures admission after the 20th day of a month, the amount will be paid from the month following the month of admission.
2. **Fees:** - Scholars will be paid enrolment/registration, tuition, games, Union, Library, Magazine, Medical Examination and such other fees compulsorily payable by the scholar to the institution or University/Board. Refundable deposits like caution money, security deposit will, however, be excluded. Compulsory non-refundable fee charged by recognised institutions against free and paid seats of recognised courses can be fully reimbursed as per the

fee structure approved by the competent State/Central Government authority. However, while sanctioning scholarship against paid seats, State Governments should make the income verification compulsory.

It is worth-mentioning that the entire responsibility of verification of particulars and documents and claim of Scholarship amount to the eligible SC/ST/OBC students will be of the Head of the concerned Institution. The concerned Institution will also be responsible for any false information and fraudulent claim of Scholarship by any student under the above Scholarship Schemes.
