Notification regarding Fixation of Scholarship amount upper limit under CSS Post Matric SC/ST/OBC for the year 2015-16 onward.

Sir,

As per Instruction issued from the Ministry of Tribal Affairs, GOI on recommendation of Hon'ble Supreme Court. The Ministry of Tribal affairs and the Hon'ble Supreme Court wanted to fix the uniform criteria for claim of reimbursement Scholarship amount for SC/ST/OBC student studying in Private Institutions.

In view of above, the State Govt. has approved the Fee and Maintenance Criteria vide letter no. EDN-B-Ga(10)-2/2015 Dt. 05-10-2016 under the Centrally Sponsored Post Matric Scholarship Scheme to SC/ST/OBC Students, as recommended by the fee fixation committee for the year 2015-16 onward, as below :-

Note: - Students who pursue their studies through correspondence courses and term correspondence includes distance and continuing education for Scholarship capping of upper limit is Rs. 20,000/- if a student claim less amount, actual amount will be paid to the student which has to be paid for the Institutions/Boards/Universities as per the previous guidelines of the Schemes for SC/ST/OBC Students.

In view of above, you are, requested to issue these guidelines to all the Institutes under your control /affiliated, so that all Institutes and students are aware about the Scholarship rates.
