Revised Guidelines for "Revision and Continuation of the Centrally Sponsored Scheme of "Post-Matric Scholarship for the Students belonging to Other Backward Classes for studies in India" w.e.f. September, 2018 - reg.

Memo,

It is brought to your kind notice that Govt. of India has issue the new guidelines for *Revision and Continuation of the Centrally Sponsored Scheme of "Post-Matric Scholarship for the Students belonging to Other Backward Classes for studies in India" for the financial year 2018-19* vide letter No. 11014/31/2017-BC-I dated 18-09-2018. Following are the main amendments have been made in the revised guidelines:

- (i) Annual parental incomes have been revised from ₹ 1.00 lakh to ₹ 1.50 lakh.
- (ii) 30% of funds earmarked for girl students and 5% for students with disabilities.
- (iii) The concept of Committed Liability will not apply to States/UTs from FY 2018-19 and funds will be released to States/UTs based on National Allocation. States/UTs are liable to make provisions for funds over and above Central Assistance to cover all eligible students from their own Budget.
- (iv) If a student is found to have obtained a scholarship by false statement his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of the concerned State Government. The student concerned will be blacklisted and debarred for scholarship under any schemes forever.
- (v) Scholarship should be restricted upto two boys of the same parents /guardian. This restriction will, however, not apply to girls.

Therefore, all Head of Institution(s) are requested to kindly advertise and publicized the new guidelines of the said scheme among all the concerned students, so that student can apply online under this scheme within a stipulated time period. 
